812 Recreation Field

Cllr Edwards (Chairman) advised councillors on the suggested security measures and the need for removable bollards to be inserted when the main gate was renewed. He acknowledged and thanked residents for donating timber for this purpose.

Mr Brian Venables had offered by way of the Roodscroft landfill site, to provide clean landfill and topsoil formed into a bank, which would run along the full length of the wire fence on the field side. Boulders would be used to replace the temporary "Lego" concrete blocks in place at the field entrance. This project was an important ongoing project and would vastly improve the current security measures for the Recreation Field.

Cllr Edwards (Chairman) advised that Vicky Lintern was prepared to offer substantial play equipment to the Council as long as they dismantled it and sited it at the Recreation Field.

Mr Marc Solomon had provided a report to the Council concerning the extent of equipment being offered and suggested that it would require some remedial repair to replace rotting wood at a cost of approximately £600. The value of the equipment was estimated at about $\pounds4,000$.

Cllr Willey (Vice Chairman) suggested that an area of the Recreation Field should be fenced off to accommodate new play equipment in the future and to promote a 'play area'.

Councillors **Resolved** to note this report. All agreed.

Action - The Parish Clerk to approach Zurich Municipal concerning insurance and an engineer's safety check.

813 Councillors Reports

A Cllr Sally White - Maintenance

Cllr White advised that the picnic benches, originally taken away from the Recreation Field in order to avoid receiving any potential malicious damage from Travellers, had not been returned to their position. Cllr Edwards (Chairman) advised that the benches would be returned to the picnic area soon.

Councillors **Resolved** to note the monthly Audit maintenance report.

B Cllr Malcolm Fletcher – Bio diversity

Cllr Fletcher updated Councillors regarding three aspects-

Roundabout



Following the unplanned and unwanted cut it got from Cormac in June this year, there has been a welcome recovery of flowers, including red clover, birdsfoot trefoil, vipers bugloss, toadflax, mallow, cut-leaved cranesbill. These are not "showy" flowers, but they are vital resources for our native pollinators.

It is a mistake to think that wildflower verges will always be a blaze of colour like traditional borders full of bedding plants. The crucial thing is that they are helping to restore some of the damage that has been done by years of mismanagement. We have to get used to appreciating the finer detail of our native flora. Taking time to stand, look and marvel at. Its worth remembering too that the visual impact of wildflower verges and meadows is simply a bonus side effect. Insects pollinate some 84% of EU crops.

Honeybees are just one of the insects that do this. The majority are wild bees, beetles, flies, wasps, moths and butterflies. These need wild flowers to tide them over between commercial crops. Their larvae need a much larger variety of wild plants, including many "weeds" such as nettles, on which to develop.

As an aside, it is worth considering the carbon footprint of a tray of annual bedding plants from a garden centre:

- Plastic tray
- Often imported from Holland
- Compost often contains peat, therefore better to grow your own from seed, especially if they are self-seeding annuals that just do their own thing and save you the trouble. Or buy/raise from cuttings perennials that will give you years of pleasure and turn out cheaper. Everything you plant and keep in the soil will help to sequestrate carbon dioxide.

<u>Ragwort</u>

The Parish Council reported the growth of several clumps of Ragwort along the verge of the A388, which borders the Recreation Field to Cornwall Council Highways (Cormac).

Cormac has replied that following an inspection, it was not deemed to be a problem, and no action was required. BFPC challenged this decision, but by reply were told that Highways policy now is that no action is taken to control Ragwort if it is more than 50 metres from cattle pasture or fodder crops, and that moreover it is a valuable source of pollen for pollinators. Councillors questioned the 50 metres distance, and it was agreed to check this.

<u>Trees</u>

The plantation along the A388 has had a mixed year. The species that are doing well appear to be the birch, hazel, oak, beech, hawthorn and the dogwoods. However, the rowan (mountain ash) seems to have been attacked by "fire blight". This is caused by a bacterium. Leaves turn yellow, then brown. Unfortunately, there is no cure, and we will most likely lose them. However, there will be an opportunity to replace them with donations of self-sown trees from residents' gardens this autumn.

Last year there had been very little regrowth of "weeds" and brambles around the trees. After the sterling work done by our groundsman Nick there was little time for them to recover. However, this year they have really taken off. Not so much the brambles, but grass, thister fleabane, trefoil, hemp agrimony and others have taken advantage of the clearance to germinate and proliferate. While a few of us have done battle, the earlier lockdowns and Covid restrictions have often made it difficult. We need a new plan for the long-term maintenance.

Councillors **Resolved** to note this report. All agreed.

- **C** Cllr Malcolm Fletcher Climate Change Emergency
- Cllr Fletcher advised that Cornwall Gateway Community Network Panel has highlighted "climate change and environmental sustainability" as a key issue and from this it was agreed that a Cornwall Gateway Climate Change Working Group should be established. The aim will be to share ideas, information and create a platform for networking. The first Zoom meeting will be held on <u>16th September 2021</u>, and Cllr Fletcher will attend.
- **2.** Both Councillors Ellis & Fletcher have enrolled on Cornwall Council's Climate e-Learning course with the intention that the scheme will be rolled out to members of relevant community groups in the autumn. This would be of interest to BOTHER.

Councillors **Resolved** to note this report. All agreed

D Cllr Mervyn Ellis – **BOTHER**

Cllr Ellis mentioned the on-going wish to proceed with the cycle/walk way between Hatt to Carkeel roundabout. Cllr Fletcher advised Councillors over BOTHER's position regarding the following:-

- 1. After pressure from BOTHER, SUSTRANS have agreed to produce the final report on the feasibility of a Walk/Cycle Way from Hatt to Carkeel by mid-September at the latest (earlier if possible).
- **2.** Saltash Town Council have asked for a copy of the report to discuss at their next full council meeting in October.
- **3.** BOTHER has asked SUSTRANS for an estimate of the cost of a further report for obtaining land consents, and also the construction costs of the path.
- **4.** St. Mellion Parish Council have also now shown interest in BOTHER's project, given that the proposed path would complete the link from the earlier proposal surveyed from Callington to Hatt.

Councillors **Resolved** to note this report. All agreed.

E Cllr Dave Willey (Vice Chairman) - Signage

Cllr Willey (Vice Chairman) advised that no signs would be put up until the new security measures had taken place at the Recreation Field, but he had sourced a sign manufacturer at South West Signs. New aluminium signs would be discussed with Councillors.

Councillors **Resolved** to note this report. All agreed.

F Cllr Dave Edwards (Chairman) – Play equipment funding

Mrs Sarah Edwards reported that a 'Picnic in the Park' was planned at the Recreation Field 4th September 2021 as an attempt to raise the profile of fundraising. Becky Escott explained

that a marquee would be set up and residents would have the opportunity to discuss how they might like the Recreation Field and Play equipment developed in the future. Sarah advised that Grant funding applications were still be completed, and it was hoped that through Cornwall Council, the Parish may secure some Community Grant funds. A resident (Jane Hutton) suggested that to engage with the Community and raise funds, 'swap & sell goods' stalls could be set up along with plant sales and cakes for purchase.

Councillors Resolved to note this report. All agreed.

G Cllr Dave Edwards (Chairman) – Post Office

Cllr Edwards (Chairman) reported that the owner of the Post Office was seeking to open the shop and post office on a full-time basis 7 days a week.

Details would be presented at the Public Meeting 22nd September 2021 for Councillors to consider.


