Good evening parish councillors,

I just wanted to let you know of an incident I witnessed last week whilst I was in the playing field on Friday 4th February.

On arrival I noticed that the rubbish bin was full, right up level with the opening, but I knew that it was soon to be emptied. (I think the empty day is a Friday...that very day!)

I walked my dog in the field and whilst I was in the far corner I saw a white van turn up, flashing orange light, and a person in hi-vis got out of the van and what seemed to be empty the bin...and I presumed, replace with a clean bag.

I then went to use the bin as I had some rubbish and noticed that the new black bag had been very poorly replaced and it was not tucked over the lip of the metal inner, as that was clearly visible and that in a matter of a day or two the bag would fall in on itself and create a really yucky mess.

So, thinking that the bag was empty and I do know how to take the lid off the bin using a pointed implement in the hole to release the catches, I took it off only to find that the bin was still half or two-thirds full.

Whoever had emptied the bin had taken out the top section of debris and had not emptied the bulk of the waste.

I had some antibac with me, so with the lid off, I proceeded the task to lift the inner metal liner out to tuck the black bag over the lip. It was a disgusting task as there is liquid and rotting debris in the bottom of the bin that has not being collected...for how long???

And, unsurprisingly, today-Monday, it is absolutely full to brimming and the contractor is certainly not doing their job correctly or fulfilling their contract.

They visited at about 11 am on Friday. I took the photo of the supposedly empty bin at 11:15. The bin is well used and it does fill up fully each week, sometimes to overflowing.

It it begs the question of how long has the bin been incorrectly half emptied, leaving this rotting mess in the bottom? It is not acceptable or hygienic and certainly the PC / parishioners are paying money for their sub standard service.

This is a no way complaint to anyone within the PC, I just wish to draw your attention to a substandard service that we're paying for.

(And as I know Dave W will be bringing this up at the ops meeting, it's irrelevant to me whether this is official or unofficial correspondence published or not.

Dear Cllr Edwards,

When BOTHER first formed the PC immediately offered its support, and we're grateful for the role it has already played as a funding conduit for our walk/cycle way project.

I'm just writing to ask if you would be willing to give us help of a different kind.

As parts of the Treledan development are still in the planning phase, and discussions regarding traffic infrastructure and management on the surrounding roads are currently taking place, we're aware of the need to strike while that iron is still warm, so to speak.

Therefore in advance of the final Sustrans report, and the supplementary report on another route option, BOTHER has been contacting local landowners informally with a view to understanding their views and getting their suggestions.

We have achieved some success (if mainly in terms of knowing what isn't possible), but in certain cases an approach from the chair of the PC might stand more chance of a positive response than an approach from BOTHER members.

If you would be willing to help in this way, I'd be happy to meet or call you to explain how far we've got, and what kind of input might be most useful.
