Dear Chairman and Members of Botus Fleming Parish Council,

You will be aware that my neighbour and myself have both raised concerns over the state of the tree line which lies between our properties. It has been stated to yourselves that we consider the trees constitute an ongoing danger to both people and property. Previously both he and I have asked Cornwall County Council to allow professional management of the trees. We also asked for your support for our requests.

The recent gales have resulted in property damage. On this occasion sizable, heavy branches came down. Had the larger of the branches hit anyone in the area then there would have been clear danger of injury or to life. I attach a picture of some of the fallen branches and would welcome any inspection by yourselves. Without tree management this danger will continue and is highly likely to increase as weather events worsen and the trees become further compromised.

It would seem that Cornwall Council are not willing to mitigate the danger to Hatt residents if such risks are raised be an individual. May I now ask that you take the matter up on the behalf of residents with the County Council with a view to ensuring that the tree line is made safe before there is more damage and danger as the high winds will inevitably come again.
