#### 1026 (ii) Mayor of Cornwall

Dear Botus Fleming Councillors,

You may have heard that Cornwall Council is planning to propose a new Mayor of Cornwall. I am writing to you on behalf of the Let Cornwall Decide campaign to ask you if you would be willing to back a Cornwall-wide call for this huge change to be **decided by the people** of Cornwall, rather than by as few as 44 councillors in a single meeting at County Hall. For more details on this please see www.letcornwalldecide.com.

We are a group of residents and (some) councillors from all party and political backgrounds who want this decision to be made democratically. We have a petition running which could be debated at Cornwall Council. The campaign is being run by ordinary residents who feel strongly about this. It also has the support of a mix of Conservative, Independent, Labour and Liberal Democrat councillors. We know that some Cornwall MPs back a referendum too.

If you agree this is important for the people you represent, there are three things you might consider doing:

1. Pass a **MOTION** calling on Cornwall Council to conduct a referendum (see possible model wording below). **NB September** is soon enough (earlier even better)

2. Recommend to all your **local Cornwall Councillors** that they should let the people decide whether there is a Mayor.

3. Sign the petition yourself and **share** it on your social media.

**(POSSIBLE) MOTION WORDING:** "Botus Fleming Parish Council believes that the way Cornwall is governed is extremely important to our local residents. We note the emerging proposals for a possible change to a powerful Mayor of Cornwall with their own staff, budget and choice of Cabinet. We believe that such a system should only be implemented if the people of Cornwall support it. We call on Cornwall Council and our local Cornwall Councillors to ensure that there is a referendum of all voters in Cornwall on whether to introduce this significant change, as set out in the relevant legislation."

We stress that this is about **who decides** on the change to a Mayor. Backing this campaign does not mean you need to be for or against a Mayor – just that it should be the people's decision.

Hi Chris, Dave, Hope you might be able to help with this please...

The parents of children at Landulph school have recently been advised that children over the age of 8 will no longer have a space on the school bus.

As previously established, there is no safe walking route to Landulph school from Hatt or Botus Fleming.

This means that many families will need to make the journeys by car which is not only inconvenient, but completely incompatible with our parish commitment to the climate emergency.

Martin Worth has confirmed that he's taking it up with Cornwall council and will liaise with the school as chair of landulph council and recommends we work together with Botus Parish council too. Is this something you would be able to coordinate direct with Martin please? Or does it need to go on to a parish council agenda?

I am sure the Parish Council are aware of the complete change off use without permission of the site near Hatt Roundabout. As it was illegal, they have now applied for retrospective planning permission. I would like to ask the Parish Council to strongly object to this. The reasons I have already uploaded to the Cornwall Council Planning Web site are listed below

Many Thanks John Invest **Botus Fleming resident** 

This site has historically been used for agricultural machinery storage however now it has been expanded to be labelled Keltek Motors Plymouth Depot! They have set up business with no planning permission and are now trying to rectify the situation as Council enforcement have been alerted. There are multiple vehicle movement 7 days a week from 5 am till late at night with huge transporters trying to turn into a very poor entrance.

The entrance is just on a corner and the risk of a vehicle collision is high. This road is the main entrance to our village of Botus Fleming and can be blocked as the lorries stop in the middle of the road while opening gates.

In addition SW Water are using the site so it is becoming a multiple storage depot. Botus Fleming is a village sitting in an area of outstanding natural beauty and this site has become an evesore to the entrance to our village. It is not suitable for the vehicle movements now taking place or the visual impact on our village. I object strongly to any permission being given to continue with this.

#### **Parent Comments**

#### **Elinor Wiltshire**

 My eldest has a permanent bus place, which was given to her when we moved to the area 6 years ago and there were no local school places available for her to go to. I will now be putting her on her (council provided) transport to school in the morning and then following in my car to get my youngest to school, what a pointless waste of time and fuel cost. My driving will also be bad for the environment as it will add another car to the roads (we currently walk the mile to the bus stop in the morning, which we really enjoy).

#### Lisa Hughes

- I have a 6 year also, however the practicality and logistics of getting two children to two different places to ultimately reach the same destination does not make sense.
- Landulph school is the closest school to my home. When we chose the school, we were told that a school bus was available throughout all school years. This was a large factor in choosing the school.
- Yes, work arrangements have are based on the scheduled bus timetable of 8.35am departure; there is insufficient time to change my working hours and early drop off for little owls will still involve travel time and cost which is not cost effective every day for two children.
- I am physically able to walk to school however this would not allow me to complete my working hours. Whilst I could walk, making both my children (including my 8-year-old) walk 34 miles each week (6.8 miles a day) would have a significant impact on their concentration whilst at school.

#### **Becky Trambath**

- Driving to school would add 17 miles a day to my usual journey. This would be because to get to work (still being late) I would need to take my youngest child to childcare in Saltash before the school run
- I would lose hours (and potentially my job) as I would be late for work and have to leave early every day.

#### **Bethan Ross**

• We have and would definitely consider moving back to Saltash to be nearer a school within walking distance as cost of living is escalating, taxes and petrol costs are ridiculously high.

#### Laura Yates

• This puts a huge strain on my husband and I with regards both work and finances. It also worries me about traffic in the lanes at an already busy period and the lack of parking at school as well as other points we've raised already. The bus has been free for decades due to it being an unsafe walk to the local school and should be reinstated before accidents occur.

#### Vicky Cochrane

• My partner Adrian and I both work full time. We rely on family members that live locally to take our daughter Ele (age 8) to the school bus and from September will also be taking our second daughter Jessie. This allows us to work for our start times of 7/7.30. Ele then usually comes back on the bus and again family members collect her and care for them until we finish work just after 5/5.30. These family members have children that also go to the school however they are under 8 and therefore at the moment will still be able to travel to school via the school bus. From September due to Ele not having access to the school bus we will no longer be able rely on a family member as they also has work commitments. As school breakfast clubs do not start until 7.45 and afterschool clubs finish at 5.30, with travel time included I simply have no option but to consider finding a new job!!! The stress this is causing myself and my family is a concern in itself and could have been avoided if communications regarding the bus situation was shared at an earlier date. Trying to sort things over the summer holidays when the school is shut is very difficult.

#### Vicki Lintern

Even though the walking distance from Hatt Bus stop to Landulph school has been deemed acceptable for children over 8 years old, the reality is that the terrain (steep hills, single lanes with large agricultural vehicles, few passing places) means the walk would easily take over an hour. Our youngest child could not walk that distance to school, so she will need to take the free bus space allocated. But, if we wait at the bus stop with her until the bus leaves at 8.35, we won't have sufficient time to get our elder child to school. I note also that this change will disproportionately affect women, which is completely at odds with Cornwall councils stated levelling up policy described in the Council's <u>Equality</u>, <u>Diversity and Inclusion strategy</u> which states key commitments to deliver better outcomes for those living and working in Cornwall through levelling up life chances across the diverse communities of Cornwall.

I am writing this letter to Botus Fleming Parish Council on behalf of the residents of Carlton Villas (numbers 19 / 26) in order to express our concerns of what we believe to be an extraordinary meeting, that I happened to witness, purely by chance, between our local XXXXXX Councillor XX and a Mr XX. A XX the Local Council Housing Assistant also attended the meeting. I should state that not a single resident was invited to attend this meeting? I then approached this meeting. I then asked Councillor XX what was the purpose of this meeting? Cllr XX then introduced Mr XX to me. I then repeated what was the purpose of the meeting? Cllr XX promptly replied that Mr XX was looking at the access into Orchard Meadow because he had bought the land and intended to build 3 or 4 houses there using the back lane as access. and vulnerable residents. Councillor XX then advised Mr XX that it might be possible to "remove the path" and then "put down 2 white lines and a yellow line outside of that". In conclusion I must say that the residents of Carlton Villas are very disappointed that Councillor XX seemed to be putting what seems to be profit before safety. I would like Botus Fleming Parish Council to find out what the situation is with the planning application and access. The residents would also like to know why and in what capacity Cllr XX was at the meeting and who was he representing, Cornwall Council or Landulph Parish Council or as an adviser? Many thanks.
