Dear Chris,

I had a chat with Martin Worth last week concerning the ongoing works to properties in Sunnybanks, Hatt, and in particular the amount of noise pollution emanating from the use of hammers and nail guns. Whilst I appreciate that buildings need upkeep and some disruption is inevitable living in a village community, there has been an intrusive continuous staccato of loud banging blighting our lives throughout the spring and summer, particularly first thing in the morning when the builders appear to take particular delight in making as much noise as possible. Not everyone is up and about at 8am; shift and night workers, older folks, those in nearby sheltered accommodation amongst others whom this adversely affects. During the day it has been annoying to have to close windows during a hot summer just to keep the noise at bay. Environmental health concerns do not appear to be considered. This is not a new problem; there has been much house building and other works going on nearby for most of the 14 years I have been here. I feel that we are all overdue for some peace and quiet.

I am not here to cause trouble, I would simply hope that there could be some way of reducing this problem for future generations. I would suggest the preference for screws over the expedience of nails with as much pre construction work as possible done off sight before installation. Could something like this be included in a Parish Council or Cornwall Council planning directive to construction companies? Might there be other ways to approach this issue? Are planning permissions given without consideration of environmental health noise issues? Are the construction companies liable for their noise disruption? I dare say this will raise more questions too.

I have to say I'm absolutely disgusted with the state of the field with countless dog mess all over the pitch, including the new park area even to the point where the bags of mess are littered about and even tied onto the fence. I would like to know what the rules are concerning dogs being allowed to be walked on the field? The community has done a fantastic job of raising money to create a safe space for the children to play with new play equipment and now it is unsafe because of the volume of dog mess. Someone has also reported mess in the actual park area. Wouldn't the simple solution be to put a restriction on dog walking on the field??

Instead only allow dogs to be walked on the fenced off car park area of the field where the dog mess bin has been provided. It seems highly unfair that walking dogs is taking priority over our children's safety. I am not able to attend any council meetings so I hope this can be resolved now I have raised my concerns.
