#### Draft Vision for CAPs: Views Please

# Overall vision: "Bringing together local organisations and people to tackle the issues that matter to communities so that everyone can start, live and age well."

Vision themes. "Cornwall's Community Area Partnerships...

- (1) Are the space where **partners coordinate** their work in place and **get things done**
- (2) Have a **"bottom up" approach** based on localism principles, where communities are supported to take charge of their future, selecting their own goals and how to achieve them
- (3) Are **empowered to act** effectively in, and be an **influential voice** for, their areas
- (4) Are listened to respectfully and responded to in a timely and effective way

(5) Are treated and resourced with **parity**, with reference to evidence of need, and make-evidence-based decisions

(6) Have **strong connectivity** with partners and communities within and beyond their areas

(7) Fairly **balance** the needs of different communities of interest and place within their areas, including between town and rural/parish areas

(8) Promote equality and diversity within their areas

(9) **Champion town & parish councils** and act as the GO TO: PLACE where they can get support, PLATFORM where they can share best practice, and PATHWAY to progress and seek funding for projects and ideas

(10) Work closely with and help support the work of the **voluntary and community sector** 

(11) Champion **co-design** of services

(12) Support communities to take action to help each other and build their capacity to do so."

## Why new and improved area partnerships?

(1) To be better able to tackle community priorities

(2) To help deliver business plan priorities and levelling up missions at area level...

(3) ...and to help improve joint working/connectivity with communities ("working in place")

(4) New structure that can be supported effectively/sustainably through shared resources - not possible across 19 networks

(5) Opportunity to build on successes and strengths of CNPs and improve consistency.

# Working in place: wider context

- Core Council mission: "working <u>with</u> communities for a carbon neutral Cornwall where everyone can start, live and age well"
- "Vibrant Safe Supportive Communities": working <u>with</u> communities to help them achieve their local priorities and build their own considerable capacity to help each other
- Council developing new operational (officer) arrangements to help transform how we work in place, starting from April 2023:
  - Multi-disciplinary officer "Place Operating Groups" to work with communities to tackle emerging local issues, drive forward priorities and support the CAPs

Proposed Priority Roles to support vision:

#### A1. NEW ROLE: To engage on and deliver CAP Area Priorities & Action Plans ("CAP Plans")

- To progress priorities important to our communities
- Evidence-based, bringing together local and Cornwall-wide priorities
- > Feed into policy and budget-setting, with escalation process for emerging issues
- Support from: Place Operating Groups, Council Leadership Team
- Resource alignment to agreed priorities: will be analysed, with potential to realign
- A2. NEW ROLE: Specific role on two Shared Prosperity Fund programmes to March 2025

#### Community Levelling Up Programme

- -Place-Shaping: town centre improvements, community infrastructure projects, community engagement schemes on local regeneration
- -Local Delivery Frameworks
- -£400k devolved per partnership area

#### Community Capacity & Facilitation Fund

- -Developing pipeline of project proposals for larger-scale SPF funding
- -£1.2m total devolved budget across the partnership areas

Proposed Priority Roles to support vision:

#### A3. ENHANCED ROLE: Community Engagement

- Engaging communities on CAP Plans (development/progress)
- > Advising Council/partners on engagement they want to carry out within areas
- Promoting local community capacity building overseeing relevant work by Place Operating Groups; working in closer partnership with VCSE

#### A4. ENHANCED ROLE: Championing and Supporting Town & Parish Councils (CN Chairs & Vice-Chairs' proposal)

- > T&PCs place at heart of area partnerships is critical
- Opportunity to build on CNPs' work here
- Go to PLACE to get support, PLATFORM to share best practice, PATHWAY to progress and seek funding for projects and ideas
- Keen to work with T&PCs/CALC to develop this proposal
- Key Question for Town & Parish sector: How can the CAPs best help you from a practical point of view?

#### **Function: List of specific roles – additional items VIEWS PLEASE**

**B1. NEW ROLE:** Oversee and advise on prioritisation of **Devolution Programme** for their areas, including associated capital funding.

**B2. NEW ROLE: External Funding:** Seek additional funding to support CAP Plans – activity to be carried out by officers within defined offer

**B3. NEW TOOL: Participatory Budgeting/Democracy** Ability to use to inform allocation of funding etc

**B4. NEW TOOL: Community Chest:** Members would have discretion to align some of this to CAP Plan priorities.

**B5. ROLE CLARIFICATION: Cornwall Council Budget:** Defined role in being engaged on annual budget process (historically ad hoc).

**B6. NEW ROLE: Business Plan & Budget:** Assessing, challenging, advising on how Council is implementing its strategies and spending its budget at area level – supports Levelling Up

**B7. NEW ROLE: Place-based services:** Similar role in relation to service provision. **Key Question: Which services do you want to focus on?**

### Function: List of specific roles – additional items VIEWS PLEASE

**B8. ENHANCED/CLARIFIED ROLE: Planning.** (i) To be engaged on development of statutory **planning policy** i.e. Local Plan, (ii) to be engaged on **planning briefs** of interest across area, (iii) to provide forum for parishes to engage on **NDP development** [to date, all ad hoc]

**B9. NEW ROLE: Children & Young People.** Defined engagement role including linking to Cornwall's Annual Conversation between children, young people and council leaders

**B10: REINTRODUCED MECHANISM: "Portfolio Holder engagement"** Cabinet Members assigned to each CAP (as in pandemic) to strengthen connectivity

**B11. ENHANCED/CLARIFIED ROLE: Local issues/service changes:** Right to be engaged, at Members' request, where impact on all or significant part of area.

**B12: NEW TOOL: Scrutiny referral:** Develop mechanism to request Overview & Scrutiny Committees to consider scrutiny when common concerns arise across several CAPs



## **Draft Geography for CAPs –** VIEWS/SUGGESTED AMENDMENTS PLEASE

- CN Chairs & Vice-Chairs have created draft geography for further engagement
- Parameters given to CN Chairs:

-12 CAP areas (upper number Council can sustainably and effectively resource) -Principles they developed at their earlier workshops

- CN Chairs themselves decided to use Community Network Area boundaries as basis for their work, as broadly coherent and reflect communities of identity and interest
- CN Chairs reached a fairly broad consensus:

   -complete consensus on 7/12 CAPs
   -two options covering the remaining 5/12 CAPs, located in "South Restormel" (CN Chairs preference is Option 1) and "West Cornwall/Camborne Pool Illogan Redruth"
- Through engagement, seeking views (and any amendments within above parameters)
- Display schedule/maps

#### **Community Area Partnership meeting** (to replace the Community Network Panel)

- Members: Cornwall Councillors/Town & Parish Councils
- Other key local partners:

-Current CNP approach (generally) – partners invited on an issues basis

-Proposed approach (for views) – invite specific partners to join as co-opted members to strengthen partnership approach. If supported, some questions...

- > Which partners?
- Should this be consistent across Cornwall...
- Or should CAPs have complete/some local discretion?
- Should partners have voting rights and in what circumstances?

#### Community Area Partnership open public forum

- To help strengthen connectivity/involvement (alongside e.g. Let's Talk)
- Various potential approaches e.g. public question time or more informal engagement
- Would meet before each partnership meeting...
- With special sessions on CAP plans (priority setting and progress)
