PUBLIC MEETING OF THE PARISH COUNCIL

Wednesday 25th January 2023

Members of the public were permitted to speak on each Agenda item for a period of 3 minutes. This meeting was advertised as a public meeting and as such could be filmed or recorded by broadcasters, the media and members of the public. The public were advised that whilst every effort is taken to ensure that members of the public would not be filmed, it could not be guaranteed.

Minutes 25th January 2023

1096/2023 Chair's Welcome & Announcements

Cllr Willey (Vice Chairman) welcomed residents to the Public Meeting of the Parish Council and delivered Health and Safety housekeeping rules.

Social distancing and Covid-19 measures were observed, such as ventilation. No one intended recording the meeting.

1097 Public participation

Amanda Holland (resident) advised of recent flooding to her property at Sunnybanks due to a blocked drain. Cllr Willey (Vice Chairman) advised that the drain and maintenance was the responsibility of the Highways Agency. County Cllr Worth agreed to a site visit with Will Glassup (CORMAC) Manager. Councillors acknowledged that drains do become blocked but that residents installing any flood defence to their property should ensure that they are not diverting excess water to the property of other residents in Sunnybanks.

Steve Malcolm (resident) complained about the state of the road at Cross Park Farm (Camomile Cottage) noting that in his opinion the slippery and poor surface of the road caused his wife's horse to slip and for Mrs Malcolm to fall from her horse.

Any Liability claim would have to be directed to Cornwall Council Highways team.

The Parish Council acknowledged that several attempts had been made by Councillors with (CORMAC) over the years to improve the road surface at Cross Park Farm, without success, following inspection of the area.

A site visit would again be arranged with Will Glassup (CORMAC) to carry out another inspection with Mr Malcolm and Councillors present. Cllr Worth would arrange the Meeting with Parish Councillors in attendance.

1098 Presentation by BOTHER – Walk/Cycle route

Margaret Matthews representing the BOTHER group provided an update on the progress of the Walk/Cycleway Hatt to Carkeel.

Background

A survey of residents' views concerning a walk/cycleway was conducted in 2021. In the light of survey results, a report produced by the national walking/cycling charity Sustrans, and the responses of local landowners, BOTHER (Botus Fleming and Hatt Environmental Response) proposed a route (see Map 1 below). This route differed in part from that favoured by Sustrans because of problems regarding land-use consents.

Recent developments

Following public meetings in June to present and discuss its proposed route, BOTHER requested a meeting with representatives of Cornwall Council. This took place on 1st July, and Cornwall Council Highways then commissioned CORMAC to evaluate the proposal.

Although it had become clear that one segment of any walk/cycle path between Hatt and Carkeel would necessarily pass through Treledan, requests made in 2022 to meet with those responsible for Phase 2 of this area's development could not be granted, as it was not known which company would acquire the contract. This uncertainty has now been resolved, and Bloor Homes have been identified as the new developers. A meeting was held on 13th January with Cornwall Council's case officer for the development, at which BOTHER outlined suggestions for the final leg of its proposed path. At the suggestion of the case officer, a request for a meeting with Bloor Homes' representative has now been sent via Cornwall Council's Community Link Officer.

Meanwhile, CORMAC submitted its report to Highways in December 2022, and it was presented to BOTHER at a meeting on 9th January. The report included a proposal for an alternative route between Roods Corner and Treledan (see Map 2 below). BOTHER members have been inspecting the new segment proposed in the report, and are preparing to give feedback on the report to CC Highways.

Next steps

It is hoped that the agent for Bloor Homes will agree to a meeting in the near future. The purpose of such a meeting will be to determine if any accommodation can be made within the new development for a segment of the proposed Hatt-to-Carkeel path.

Meanwhile, landowners on the proposed CORMAC route will be consulted regarding their willingness to allow a section of the path to cross their land.

The views of parishioners will be sought, as well as the views of councillors from neighbouring parishes. This process has already begun. As soon as possible, feedback on the CORMAC report will be submitted to Cornwall Council.



A Cllr Sally White - Maintenance

Remedial repairs carried out on the Botus Fleming Noticeboard. Thanks to Richard Taylor (resident) and Cllr Willey (Vice Chairman).

The small gate to the Recreation Field had been left open recently.

The wooden benches had been tipped over. Cllr Willey (Vice Chairman) suggested that this may have been as a result of windy weather. Consideration would be given to concreting the benches into the ground in future.

B Cllr Malcolm Fletcher – Climate and Ecological Emergency

Cllr. Fletcher reported as follows-

1. A388 Tree Plantation.

It will be three years in March since the initial planting was done. Most have survived and even thrived, with several additions each year, resulting in a mix of some dozen species. BFPC needs to decide on a longer-term management plan for them now. Left alone, the brambles will gradually reclaim most of the site. In a few more years the young trees will be able to cope with this, but in the long term it would be preferable to keep access easy for residents to be able to view the trees close up. I don't want them to be like a museum exhibit in a sterile glass case.

2. Landmark Tree.

Forest for Cornwall do not seem to reply to any requests for updates on this.

3. Hatt Roundabout.

Given the increase in the cost of the contract for grass cutting in the village, BFPC decided to hand over this work to Cormac as was previously the case. Cormac's grass cutting regime now accords with the approach advocated by BFPC to increase biodiversity. This means that the roundabout will be cut twice per year: once in Spring and another in late Summer/early Autumn. This will not include a safety cut along the north-south diameter. BFPC might be able to negotiate this with our contractor.
