# 1159 A Report from Cornwall Councillor Martin Worth

Cllr Martin Worth updates -

### **Refuse changes**

It will be on the same day as usual (Tuesday) in Botus Fleming. Refuse must be outside before 07:00 hours please.

Changes to rubbish and recycling collection times are as Cornwall prepares for new food waste service - Cornwall Council.

To help residents recycle more and reduce their rubbish, Cornwall Council will be making changes to residents' household waste collection services. Cornwall Council will introduce these changes area by area in stages across Cornwall starting in 2023.

- Cornwall Council will provide a new separate weekly food waste collection service.
- Rubbish and recycling collections will be fortnightly.
- Cornwall Council will give most households a wheelie bin to protect their rubbish.
- If residents don't have anywhere to store or put a wheelie bin out for collection, Cornwall Council will give you a reusable protective sack instead.
- To help you recycle your food waste Cornwall Council will give residents a lockable food waste bin to store it in.
- If residents live in a flat, apartment or property with shared bins, Cornwall Council will be looking at residents current collection arrangements and making any changes with their particular circumstances in mind.

### **Housing Crisis**

Cornwall Council have over 700+ people in Temporary Accommodation in Cornwall, costing us all £10m per year. We have a Homechoice list of those waiting for Affordable homes or over 22,000 families. We have 40,000 private Rented Properties in Cornwall which need to be upgraded to EPC "C" Energy level by 2028. To encourage landlords to stay in the market,

grants of up to £60k are now available. Also grants to Landlords with Tenants in properties who are 6 Months in arrears. Minimum Energy Efficiency Standards - Cornwall Council

### Botus Fleming Water Pipe A388 Congestion

South West Water undertook the essential roadwork in March/April 2023 and Cornwall Council Street Works approved the Road space. Cornwall Council Street Works under the Highways Act, cannot stop essential works being undertaken by utility companies. South West Water has applied to, install a new water main using directional drilling (this reduces the excavation time and speeds the process).

Cornwall Council Street Works have applied additional stipulations to the contractors using the Road space; this was to decrease the congestion and potential issues. This includes having the traffic lights manned between the hours of 07:00-09:30 & 16:00-18:30 and keeping the site length to a minimum of 300 metres.

The CORMAC Highways Manager responded: "Unfortunately, traffic who decide to not wait at the traffic lights and find alternative routes, by either local knowledge or SatNav, is almost impossible to manage. The only way to mitigate this, would be to apply road closures to the surrounding areas. This would then cause additional issues for residents who live in the area and people who would need to access Botus Fleming. I understand the works are an inconvenience but as with all road works, the disruption will be short lived. I would recommend any additional issues with the works, are raised with South West Water direct".

A Cllr Sally White - Maintenance

**B** Cllr Malcolm Fletcher – Climate and Ecological Emergency

Cllr. Fletcher reported as follows -

## 1. CORMAC and Verge Cutting

A lengthy enquiry was sent to CORMAC asking for more detail as to how they will cut the Hatt roundabout. Their reply was simply that it would be cut once in Spring/early Summer and again in Autumn. They could not give any more definite dates than that. We can only hope that the cuts are done at such time as to maximise flowering and seed-setting opportunities for the plants there. However, residents can be assured that all is done according to Cornwall Council standard procedures and is out of the hands of the Parish Council.

### 2. Climate and Ecological Emergency Bill

Cornwall Council voted last week to support the Climate and Ecological Emergency Bill that is currently being considered by Parliament. This Bill seeks to reinforce the current measures being considered by the government in as much as it would oblige it not only to halt the ecological decline but also to take measures to add to our biodiversity.

3. A resident has volunteered lead a small group of volunteers to sow some "Bee Bomb" wildflower seeds on a patch in the playing field. Councillors will be consulted as to the location of this.

**C** Cllr Mervyn Ellis – BOTHER

Cllr. Ellis reported as follows -

BOTHER has been waiting to attend a meeting with James Hatton (CC Transport) concerning its feedback on the route for the middle section of a walk/cycleway proposed by CORMAC in a recently commissioned report.

The suggested April meeting didn't take place, and James has now deferred until May, when CORMAC will have submitted its finished plan for the design of an upgraded intersection at

Roods corner. Meanwhile, CC has asked CORMAC to incorporate flexible provision for th walk/cycle path in its design.

The Big Event committee has agreed to allow BOTHER to have a stand this year

# **D** Cllr Malcolm Fletcher – Defibrillator

Cllr Fletcher confirmed that the monthly check on the new defibrillator situated at Hatt garage had been carried out. The defibrillator was charged and thanked Cllr Robinson for carrying out regular inspections of the unit.

Following consultation with the Chairman of the St. Mary church P.C.C. it is the Church's intentions to re-wire the hall. An isolation switch could be installed as the electric feed for a defibrillator to be located at the hall along with movement detector lighting. The estimate of these costs and the Parish Council's contribution is not yet know.
