To the Clerk and Councillors of Botus Fleming PC

I attended the last P.C meeting dated 28.06.23. and was asked the question, as a dog owner what were my thoughts about the playing field. At the time I wasn't really aware of the situation and therefore possibly didn't express my views fully. I believe the matter will be discussed further at the next meeting and if I am unable to attend, I would like to express my thoughts by enclosing the following.

Firstly, as a dog owner I can fully appreciate that dogs can be a nuisance to others and even a danger. With that in mind I hope that as a responsible dog owner I take care to prevent my dog from the kind of behaviour that does affect others. Like most things in life the minority will always spoil things for the majority. It is also important to consider the well being of the dogs themselves. Just like humans, dogs need physical and mental activity. For a rural area its amazingly difficult to find a safe space that dogs can run free. I would whole heartedly support a total ban on dogs from an enclosed area around the play equipment and it would seem common sense that dogs should be on leads during ANY events held in the field, whether it's an organized sports match or something like the Big Event.

I would also like to look at this from another point of view, not as a dog owner but as someone that has spent a lot of time and effort helping others maintain and improve Hatt recreation field. I don't have children and therefore have no use for the play equipment, but I have helped raise money for the new equipment and continue to help, in a small way to maintain the donated equipment. I've only done this work because I believed that the field was going to be for ALL and not just children.

It does seem that the ones to have benefited most from the improvements at the playing field are the parents and children. It also seems that those that complain the most are the parents. I would go further and say those that do the least amount to help are the parents. Trying to get help, from parents, to do anything in the field is extremely difficult. It is very noticeable that the biggest effort within the field has been from members of the community that DO NOT have children but may have dogs. I would therefore, find it insulting if dogs were to be totally banned from free running in

the greater part of the field, and would be asking myself why I bothered to help with the play area and Hatt recreation field improvements in the first place.

Hi Guys,

I understand the issue of dogs in the playing field is probably becoming a tedious point of discussion by now but I would just like to raise a few things.

Firstly, in what has seemingly become a "dog owners" v "parents" battle, I would like to point out that although a parent without a dog, I am certainly not anti-dog.

I have had dogs in the past and will again when work commitments allow. I think its great to see people out and about walking and it has always been a great way to meet other villagers.

I have been fortunate enough to have lived in Hatt for the majority of 38 years. During that time there has always been a safe designated place for children to play, (the old 'tug of war' field where the boulders are, the brief period in the barn field opposite that and then obviously our current site from 2000 onwards. (I scored the first ever goal in that field the day it opened in case anyone was wondering?!)

Up until just a few years ago these were dog free and from what i could understand there was never any issue?

Dogs on children's playgrounds represent a major health and injury hazard:

- •Toxocariasis an infection caused by roundworm parasites, most commonly found in cats, dogs and foxes faeces. Children and young adults are usually affected due to contact with contaminated soil or sand within play areas by swallowing the infected egg.
- •There is evidence that dogs can also carry E.coli and hepatitis in their faeces.
- •There are over 7,000 admissions to hospital for dog bites and attacks annually in the U.K. and under 10's were most likely to be admitted. (NHS Digital)

Put simply, dogs and children cannot share the same area.

Whilst fencing off the play equipment solves one issue, what about the other 80% of the field?

Expecting them to share the area would heavily favour the dog owners.

No parent will put their child in an unsafe environment.

Would dog owners take their dogs there if children left things harmful to their dogs? - of course not!

I completely understand the need for an area for dogs to exercise and that this field makes for a lovely spot to do so. I would question whether taking this area away from children is the answer though?

The council should be commended on what an excellent job it has has done this past few years. Your enthusiasm and dynamism in improving the community is refreshing and something certainly not seen in my lifetime.

This leads me to have every faith that you will resolve this issue in a way that will keep everyone happy - not just a majority, and that my children wont ever be laying claim to scoring the last ever goal in the field.
