Much clarification was provided as to how the situation was being addressed by the local Police in respect

to some anti-social behaviour in the village. Cornwall Cllr Martin Worth also added stating the stance taken by Cornwall Council and their endeavours to provide extra housing in Cornwall.

Malcolm Fletcher also stated that the Homeless situation in the Country through lack of Housing was ultimately a government issue and that residents in the Parish endeavoured not to be too judgemental of others due to the homeless situation that some find themselves in.
