### Cornwall must have a Needs Budget

Communities across Cornwall are crumbling after 15 years of austerity. Fifteen years of Cornwall Council workers being squeezed ever tighter as bosses demand more work from a smaller workforce. People and services are struggling.

Three years after 410 Cornwall Council jobs went in a bid to cut – sorry, "save" £59 million, Cornwall Council is coming back for more.

A **NEEDS BUDGET** would work for Cornwall Council workers and begin the job of restoring Cornwall's communities.

#### A NEEDS BUDGET INCORPORATES THESE CORE PRINCIPLES:

- No child, no vulnerable adult in Cornwall to be a source of profit
- Every Cornwall public service privatised since 1979 to be back in public ownership
- £15 p/h minimum wage for Cornwall Council workers
- An immediate end to Right to Buy
- Addressing the housing crisis by building social housing with in-house works department
- Demanding the return of the £450 million stolen from Cornwall by central government since 2010
- No council tax rise
- Ensuring people are connected with cheap, publicly owned and run transport
- Ensuring homes are heated and work for people
- That we have access to health and social services.

#### A NEEDS BUDGET WILL:

- Rebuild Cornwall communities
- Transform Cornwall's economy
- Restore faith in Cornwall democracy
- Future-proof Cornwall against further government looting

#### A NEEDS BUDGET IS EASY

- A budget is drawn up using the core principles above
- We wave goodbye to the developers and private care sector operators who are bleeding Cornwall dry
- The gap between what is needed and what Cornwall will have (around £2 billion this year) is funded by "prudential borrowing"
- Cornwall's vast reserves (£484 million in 2021 but shamefully and shamelessly frittered away to £281 million today) will finance the interest charges on the loans

#### PROMOTING AND DEFENDING A NEEDS BUDGET IS HARD

Overturning 46 years of cuts and privatisation will take time. It is not possible to put exact figures on, for instance, creating a publicly-owned direct works department from scratch. Precise accounting is not the issue. What matters is the political will to turn around the cuts juggernaut. Just imagine if the inexhaustible wealth produced by the British people was used for our benefit, rather than hived off and deposited in offshore bank accounts.

There will furious opposition as the followers of the cuts religion correctly see that, once a foundation stone is removed, the whole shabby edifice collapses. But a mobilised working class is the most powerful human force on earth. Trade unions are central to this strategy.

#### **CORNWALL COUNCIL WORKERS – THE WAY FORWARD**

- Union organisation workers organising, discussing mutual problems and coming up with solutions together in a democratic manner is the route to transforming life at Cornwall Council
- Attend union meetings. Make a **NEEDS BUDGET** branch policy

Dear Sir,

I have lived in Hatt since 1981, and over the years I have been bitten by dogs and tripped over by dogs while jogging in the area. Dogs running at me in the lanes and in the Recreation Field while I am jogging is quite common, and as a result I have occasionally had to remind various dog owners that they have a responsibility to keep their animals under control at all times.

The reason for communicating with you today, is that while my wife and I, and our three grandchildren were playing by the goal in the Recreation Field at around midday on Thursday 21st August, we experienced a most unpleasant incident involving a dog owner.

The lady in question (who I believe is a Hatt resident) walked into the field via the entrance near the goalpost and immediately released her light-coloured labrador near us. It ran and grabbed the small ball we were playing with (I guess it was a labrador but I am not 100% sure). I tried to get the ball back from the dog but I couldn't. And when the dog's owner eventually extracted the ball from the dog's mouth, most bizarrely, she placed it behind her back and would not give it to me. When I

asked her for it and then mentioned that I would prefer not to have dog slobber over it (just to make the point that she ought to have been more considerate), she sarcastically exclaimed "oooh Covid!" and then completely lost the plot.

When I did get the ball back the woman unexpectedly launched into a tirade of abuse. She told me that I was a horrible person (or words to that effect), she asked my wife, "why she lives with such as terrible man as me." Somewhat shockingly, she even called me a "twat" - and all this was said in front of my three grandchildren, the eldest of whom is five years old. The five of us were forced to listen to this totally unexpected and inappropriate rant, not really understanding what we (or I) had done to encourage this kind of anti-social (and some might even say psychotic) behaviour. I must point out we said very little during the whole incident, and consquently there was no excuse for this aggressive and abusive behaviour.

From my perspective, I would have expected the dog owner to retrieve the ball from the dog's mouth, hand it back to me and express some kind of apology for what happened. After all, we had done nothing wrong, and if I had been placed in her position I would have apologised with a smile and that would have been the end it.

I do understand that dog owners need somewhere to exercise their animals, and I am not antidogs, but I am against dog owners who seem to believe they have priority over everyone else, and who don't take the appropriate care and accept the necessary responsibility that goes with dog ownership. I won't add any further details about the incident, except to say that this totally ruined that part of our day with the grandchilden, and I am fed up with the attitude of certain dog owners who seem to believe the field is just for them and their dogs.

I did not vote for the field and contribute to the funding to be treated in this way by selfish and inconsiderate dog owners. I hope therefore that you will note that children and adults without dogs enjoying the Recreation Field are occasionally treated as second class citizens by certain dog owners, and if there is anything you can do to get the message across to dog owners that this has to stop, I would be most obliged. Not everyone wants dogs jumping at them or slobbering over their property.

### Coronavirus reminder regarding public meetings.

Councillors are requested to note that in response to the Coronavirus pandemic, the Ministry for Housing, Communities and Local Government (MHCLG) issued new Statutory Instruments that affected the limited assurance regime process.

SI2020/392 and SI2020/808 gave Local Authorities permission to allow members, the public and press to attend meetings remotely from the 4<sup>th</sup> April, 2020 in respect to smaller authorities.

The Legislation only permits remote attendance at meetings held before the 7<sup>th</sup> May, 2021 hence, as no further Legislation has been passed, smaller authorities will not be able to hold virtual meetings after this date.
