#### 14 Review of Vexatious Complaints Policy

Cllr. Willey (Chair) referred Councillors to the Council Policy, adopted 23<sup>rd</sup> May 2018. Councillors agreed that in essence there was no need to make necessary changes to the wording of the Policy at the moment.

Cllr Oakes & Cllr Smith both stated that under point 6 ' Further advice and guidance ' that 6.3 be added stating that Full Council should have the option of referring a Complainant's case to the Standards Committee Cornwall Council, should criteria within the Policy wording be met.

**Proposal for Full Council** : that Item 6.3 be added to the Vexatious correspondence and complaints policy. All Councillors agreed.

#### 16 To consider a Complainants Case

The Sub Committee Councillors considered the briefing documents thoroughly, namely, the Complainant's case listing matters from November 2018 to October 2019, and also the Botus Fleming Parish Council response dated 24<sup>th</sup> October 2019.

Councillors concluded that within the Vexatious correspondence and complaints policy (adopted 23 May 2018) that under Item 2.0 'Defining vexatious correspondence or complaints', that points 2.1 (a), (b) & (e) had been breached and met the criteria of a persistent and frequent vexatious complainant in the opinion of Botus Fleming Parish Council.

Cllr Willey (Chair) proposed that these points be put to Full Council 11<sup>th</sup> December 2019 and that the Complainant case should be referred to the Standards Committee Cornwall Council as soon as practicable as recommended by the Sub Committee.



**Proposal for Full Council :** that the complainant case as mentioned in Item 16 paragraph 1, be referred to the Standards Committee Cornwall Council.
